RULES & INFORMATION FOR GUMBO COOK-OFF

1. No entry fee is required. Each team will be assigned a space with a 10 X 10 tent, 2 tables with linens and tasting cups/spoons.
2. You must prepare 5 gallons of Gumbo, supply your own serving utensils and method of heating. Access to electricity is minimal and you must supply your own extension cords if you must have electrical access.
3. Gumbo may be prepared ahead of time and re-heated at time of event. It may be seafood, non-seafood or a combo of both.
4. **You need to be checked in and booth set-up by 2:00pm. You must be ready to serve by 2:30pm. Details for check-in and load-in will come closer to the event.**
5. You must provide your own hand washing station in accordance with Summit County Health Department regulations.
6. We encourage all teams to decorate their booths and dress festively!
7. Judges will be voting for 1st, 2nd & 3rd place. Guests will be voting on "People's Choice."
8. Judging Criteria as follows:
 - Aroma– should smell appetizing
 - Appearance– should have an appetizing color
 - Consistency– should be a smooth combo of ingredients & roux
 - Taste– should taste good
 - Aftertaste– should leave a pleasant taste after swallowing

****each category is ranked 1-10***
9. Awards will be announced at 5:00pm. 1st place is \$250, 2nd place is \$150 and 3rd place is \$100. People's Choice will receive a plaque.
10. Guests will purchase a wristband for \$10 in which they will be able to have unlimited tastes from each participating vendor. All proceeds benefit the SRCA. No vendor is to sell any items.

Agreement:

I understand that I will supply 5 gallons of gumbo to be served to the judges and guests. The 5 gallons of gumbo can be either Seafood, Non-Seafood or a combination of both. I understand I will supply all ingredients for the Gumbo and that it can be cooked in advance. I also understand that The Keystone Neighbourhood Company will supply the tasting cups and utensils for the gumbo to be served in.
