**DO NOT** include booth fee payment with your application. The World Music Festival has a limited number of booth spaces. The event coordinator will notify vendors, artists, and/or artisans of acceptance via email on or before Friday, April 30, 2010. All booth fees will be due after notification of acceptance. **Please note that your application will not be considered without inclusion of application processing fee.**

**BOOTH SPACE**

A single booth is 10X10 feet, and a double booth is 10X20 feet. Vendors are to provide their own freestanding display booth. All spaces are on pavement outside. Electricity is limited. Post-festival security is not provided.

Festival event manager will determine booth placement for all vendors. Previous booth placement does not determine booth placement for the 2010 show.

Booths will be configured in standard art show placement, side-by-side. Please plan to sell your wares out of only one side of your booth. If you would like to request a booth that allows you to sell out of more than one side of your booth, please apply for a double booth space.

**FEE INFORMATION**

- Non-refundable application fee - \$10. Due with application. Applications not accompanied by application fees will not be considered.
- Booth Fee - \$235 (single booth; 10X10') or \$365 (double booth; 10X20'). Due after acceptance notification Friday, April 30, 2010. Due June 1, 2010.
- Cancellations before June 15, 2010 will receive a full refund for booth fees.
- Cancellations on or after June 15, 2010 will not receive a refund of any kind for booth fees.
